What did you learn from your parents / grandparents and what would you like to pass on?



What does the family experience of the Shoah mean to you?

Burden and commitment. This division is justified because the burden is given, but the commitment is chosen. All of us in my generation witnessed the trauma of our grandparents and its transmission to our parents' generation, but in adulthood, we have gone from being mere witnesses to actors in a family history that we pass on. Looking back, I realize the extent to which my family's experience of the Shoah influenced, shaped and directed me.

What have you learned from your parents/ grandparents that you would like to pass on?

My parents taught me respect for the parents. It's not just an empty phrase to me. I try to pass on the relationship to my ancestors and family roots to my daughter.

What is important to you in life?

Ordinary but precious things, i.e. health, family, friends... Everything my grandparents' generation lost.





FOREWORDS OF THE CHAIRMAN OF THE BOARD OF DIRECTORS



In 2020, the Czech Republic was among the most affected countries by the Covid-19 pandemic. The most vulnerable were the eldest, i.e., those people, who are supported by a large part of the activities of the Foundation for Holocaust Victims (FHV). Of course, the activities of the FHV were limited by government measures, as were the activities of other organizations. Our activities had to be carried out in full scope, though, under very difficult conditions.

The Board of Directors and the Supervisory Board held most of their meetings online, without a possibility of personal contact. Nevertheless, the statutory bodies of the FHV carried out their activities in accordance with the foundation charter and in accordance with Czech law. The secretariat of the FHV worked as far as possible at the headquarters of the organization and, in addition to the routine agenda, performed the extraordinary tasks associated with the pandemic.

The Foundation for Holocaust Victims was involved in the flexible assistance to the elderly and older members of the Jewish communities. The FHV also distributed an emergency aid provided by other organizations such as Czech-German Fund for the Future and the Embassy of the State of Israel. This emergency aid is explained in more detail further in this annual report.

As every year, the main activities of the fund were the announcement, provision, and administration of grants in our programs: Care, Remembrance, Renovation, Future and Our Future. The FHV has invested its funds in such a way that even the financial market downturn caused by the pandemic did not threaten our investments and the overall annual result of investments was positive.

On behalf of the FHV, I would like to thank very much to all the donors who, through the FHV, have contributed to the projects that we have supported and, of course, especially to those donors who have responded quickly to the threat posed by the coronavirus and provided the means to defend against it.

I thank the staff of the FHV Secretariat for their extraordinary personal commitment during the pandemic. Without their work and dedication, the FHV's activities could not work without any interruption. And of course, I also would like to thank my colleagues from the Board of Directors and Supervisory Board for their continued work in difficult conditions.

MISSION STATEMENT AND ACTIVITIES

WE MITIGATE THE INJUSTICES OF THE PAST, WE THINK ABOUT THE FUTURE

The FHV was established in 2000 by the Federation of Jewish Communities in the Czech Republic based on the recommendation of the Joint Working Committee focusing on the mitigation of some property injustices to Holocaust Victims, to organize educational and cultural activities in Judaism in the Czech Republic.

Endowment benefits have been awarded in grant programs for 19 years:



CARE

social, health and psychological care for holocaust survivors



REMEMBRANCE

Remembrance and educational projects on Holocaust



RENOVATION

Renovation and maintenance of Jewish monuments in Bohemia and Moravia



FUTURE

Education in Judaism and the development of Jewish communities and for 8 years also in the sub-program **OUR FUTURE** projects for Jewish families with children.

In the years 2001–2005 we administrated the **Compensation Program**, in which we distributed CZK100 million among those, whose property in today's Czech Republic had been confiscated during WWII based on racial laws and who were unable to retrieve it or receive other forms of compensation through the then applicable restitution laws or through the international agreements. The program has been closed for several years now and our Foundation is currently not dealing with claims of this kind in any way.

We support the projects by organizing our own activities, especially by organizing expert seminars for social workers, care providers and psychologists of Jewish organizations that provide care to the Shoah survivors and their families. We also organize and support the Mechanchim seminars for Jewish teachers, lecturers, and community workers. We are also focusing on community development, preparing the café sessions (Three Generations and I am Jewish, and I Prosper) and celebrating Hanukkah in public spaces. Every year, together with the Federation of Jewish Communities in the Czech Republic, we organize a commemorative meeting on The Day of Commemoration in Memory of Victims of the Holocaust and Prevention of Crimes Against Humanity on the premises of the Senate of the Czech Parliament. We are preparing an educational seminar connected with a visit to the former Auschwitz-Birkenau extermination camp.

The FHV is mainly funded from state resources. In the year 2000, the Government of the Czech Republic, transferred CZK300 million to the FHV's account from the National Property Fund. In December 2014, the FHV signed an agreement with the Ministry of Culture of the Czech Republic on a five-year financing period in which a yearly endowment benefit, amounting CZK20 million, was transferred to FHV's account. The Government finances the projects in all grant programs excluding the Care Program, which is financed from the FHV's own means. On 3 June 2019, the Government of the Czech Republic decided by Resolution No. 387 on further support for the FHV in the years 2020–2024 totaling CZK100 million. The subsidy will again cover the Renovation Program, Remembrance Program, The Future Program, a Sub-Program Our Future and part of the administrative costs.

Care, Remembrance, Renovation, Future and Our Future

The Foundation for Holocaust Victims supports projects based on a public tender. The call for proposals is announced once a year, usually in July, and the deadline for projects is September. The projects are realized during the following year.

- The FHV supports projects prepared especially by organizations under the umbrella of the Federation of Jewish Communities in the Czech Republic, associations, public beneficial organizations, institutions established by the church, public service institutions, and allowance organizations.
- All organizations must be registered in the Czech Republic. Natural persons are not entitled to ask for endowment benefits.
- We only support projects that are realized within the territory of the Czech Republic.
- The endowment benefits are granted for a period of 11 months, and in case of Care program the period is one calendar year.
- In Care, Remembrance and Renovation Programs, there is no limit for a maximum requested amount. The maximum amount of the endowment benefit within the Future Program is CZK50,000 and within Our Future Sub Program it is CZK100,000.
- We favor projects having various financing sources.

All applications are processed through Grantys – an Electronic Grant Database at https://nfoh-granty.cz/.

The applications are evaluated by the respective grant committees

nominated by the FHV Board of Directors. The Board of Directors grants endowment benefits based on their recommendation. The results of grant call are published on the FHV website, and all applicants are informed in writing.

We sign contracts with all our successful applicants. Afterwards we follow and review the use of the monetary means during the implementation of the project. The supported organizations present the FHV with progress and final reports on the projects, as well as reports on the budget. In case of any violation of contractual terms and conditions, we demand the return of the granted money. All projects are subject to an audit. We actively participate in projects we supported and in case the beneficiary asks, we help with the promotion of the projects. Projects in the Reminder, Renovation and Future (including the Our Future sub-program) are funded by the Ministry of Culture subsidies, the Care program is financed from our own financial resources and the donations we receive.

In 2020, the FHV and the financial means from the subsidy received from the Ministry of Culture of the Czech Republic supported the total of 125 projects.

The FHV Board of Directors selected on 23 November 2020 a total of 145 projects, which we will support in 2021 with the amount of CZK21.5 million.



For nineteen years we have been supporting projects that provide professional social care, health care and psychological care for Holocaust survivors and their families. Through collaboration with professionals, we strive to improve the quality of their lives and provide the best care at their old age. We shall not forget about the survivor's second generation. We financially support home care, nursing services, psychological aid, residential care, day care centers run by Jewish communities, social workers, social advisory services, personal assistants, medical care, occupational therapy, physiotherapy, rehabilitation, phone contact services and many other activation programs. The care for Holocaust survivors and their families has been our long-term priority.

In 2020, everyone faced a Covid-19 pandemic and had to adjust their lives to minimize the risk of contracting this disease. Social services were very busy and in great demand. The clients of Jewish communities, thanks to the high commitment and dedication of social workers, received services without interruption and had the necessary care provided, including the provision of protective equipment, necessary food supplements and vitamins. We actively cooperate with the Federation of Jewish Communities, which coordinates the financing of care from the Claims Conference in the Czech Republic. In total, we support the care for about 350 clients.

REMEMBRANCE PROGRAM

Our support is aimed at projects emphasizing a dignified remembrance of Holocaust victims and the victims of Roma genocide during WWII. We focus our attention to the education of young people through supporting activities having an expert leadership and involving the participation of Shoah witnesses. We finance commemorative events and commemoration services, exhibitions, theme lectures, workshops, research papers, and publishing of books and publications.

Overview of Granted Endowment Benefits in 2020:

In 2020, 38 projects were financed within the Remembrance Program by an amount of CZK2,386,935, the source of the funds is the subsidy of the Ministry of Culture of the Czech Republic. Despite the unfavorable pandemic situation, most of the projects were implemented..

RENOVATION PROGRAM

We support the restoration and maintenance of Jewish monuments throughout the Czech Republic. Our goal is to restore the monument to its original state when the monument was built or, if this is not feasible, we then restore the monument to the state that would capture the maximum of the architectonic, artistic, and artisanal elements.

We finance the repairs of synagogues, rabbinic houses, and Jewish cemeteries. We also support re-erection and repairs of knocked-down tombstones, restoration of valuable tombstones and reconstruction of fencing walls. Our financial means do not enable us to restore all tombstones, so we also support cemetery documentation to have a digital image of its look saved for the future generations. All projects are led by professionals.

HELP DURING THE PANDEMIC

The coronavirus pandemic has significantly affected our activities. Thanks to the grant of the Ministry of Culture, we supported projects in our grant programs. For some organizations we remained an important partner for projects and allowed projects to be implemented even in an amended form.

From the very beginning, we tried to be helpful, especially to the survivors of the Shoah and their caregivers.

Immediately after the first lockdown, we bought suitable fabrics and asked the seamstress, Zuzana Němcová, to sew the face masks, which were in short supply.

Thanks to the project "Face Masks to Seniors" and the cooperation with Judita Matyášová, on 26 March, we received 100 sewn face masks, which we handed over to the social department of the Prague Jewish Community.

On April 3, we acquired for EZRA, the comprehensive home care of Prague Jewish Community and for Charles Jordan's family hotel, at that time completely inadequate protective equipment, namely 100 protective suits, 10 face











shields and 34 liters of disinfectant. The donors were a group of volunteers and companies organized by, among others, Simona Bagarová from the Management for NGOs, and Judita Matyášová.

On 22 May, we received an exceptional aid in the amount of CZK 200,000, to help survivors of the Shoa during the coronavirus pandemic. The support was given by the Czech-German Fund for the Future. From this aid we purchased protective and hygienic aids, vitamins, and food supplements to strengthen immunity. The project involved Jewish communities in Brno, Karlovy Vary, Liberec, Pilsen, Prague, Olomouc, Ostrava, and Teplice.

In the summer we organized the cooperation between Živá Paměť, o.p.s. and the Social Care Home Hagibor, which led to financial support for the services provided.

In cooperation with an Ambassador Daniel Meron and the Embassy of the State of Israel, we implemented a joint project and on the eve of the Jewish New Year, we purchased protective



equipment for Jewish communities outside Prague in the amount of CZK 22,300.

In November and December, we catered to volunteers who donated their time and helped in a critical situation at the Hagibor Social Care Home with the care for our most vulnerable seniors.

Towards the end of the year, we started preparing another application for exceptional support from the Czech-German Fund for the Future, for the first half of 2021.

We would like to thank to all our donors, volunteers, co-workers, especially social workers, caregivers, and psychotherapists. ♥

PROJECTS OF OUR OWN

For many years, we have been supporting the projects by organizing our own educational and cultural programs. We prepare the programs for our partner organisations, possibly in cooperation with them. We maintain contact with those organisations, we map the needs of their employees and actively look for ways to help, particularly Jewish organizations, in their work and activities. We are also aware of the community overlap of our work. That is why we organize cultural events that help to enrich and improve community life in Jewish communities, while also helping Jewish organizations with the preparation of projects that develop their social life.

We Educate

Workshops for Social Service Workers

The care for Holocaust survivors and their families has been our priority. We regularly organize education and meetings of social workers of Jewish communities in the Czech Republic. We prepare seminars with an accreditation of the Ministry of Labor and Social Affairs of the Czech Republic. Since 2014 we have also been organizing seminars with experts from abroad. In 2020 we prepared two accredited seminars. A seminar with a foreign lecturer was planned but could not take place due to pandemic measures.

The first meeting was held in June and its topic was the "Effective Conflict Management – Selected Techniques". The lecturer was Věra Máchová. The aim of the training program was the typology of clients who require a specific approach and clients with problematic behavior. The lec-



turer explained in detail the principles of negotiations and communication with these groups of clients while observing a professional approach on the part of the carers. The participants also got acquainted with the skills of Mental Hygiene and coping with stressful situations. The seminar was attended by 17 people.

In early December, due to the pandemic situation, the second meeting was held online. The theme was "Working with emotions in a professional relationship – how to cope with grievances and feelings of guilt." The aim of the seminar was to familiarize participants with the problems of processing emotions and emotional injuries arising in connection with interpersonal communication. The seminar was led by Věra Máchová. The seminar was attended by 11 workers.

Mechanchim seminar for teachers and workers in Jewish educational organizations

Due to government regulations related to Covid-19, this year's seminar could not be held in the traditional two-day attendance format. We decided to take advantage of this situation and turn this challenge into an opportunity. We invited a wide range of people who work in community education and community activities to an afternoon online meeting, and we chose a guided debate over our experience of hosting community events during the pandemic. The seminar was prepared jointly by Moishe House regional coordinator, Eva Šrůt, and Lauder schools representative for Judaism, Tereza Váňová.

Several concrete ideas emerged from the meeting, which were later implemented during Hanukkah. A number of activities that the participants came up with as outlined ideas, we moved together in a new direction. Many non-traditional ideas (offline fight, podcasts, sports challenges, etc.), which some participants came up with, became the inspiration for future programs of the participants of the seminar.

We developed Mechanchim and started holding follow-up meetings called Be Café, where we



discuss community plans and coordinate activities before individual holidays. The meetings are held online, the first one took place before Hanukkah. We plan to continue with them next year. We would like to thank the American Jewish Joint Distribution Committee for their cooperation and support.

We Remember

The Holocaust Remembrance Day and the Day of Prevention of Crimes Against Humanity

In cooperation with the Federation of Jewish Communities in the Czech Republic, we organized a traditional Holocaust Remembrance Day and the Day of Prevention of Crimes Against Humanity in the Senate of the Czech Republic. The event was held with the auspices of its President on 27 January 2020.

The meeting was affected by the sudden passing away of the President of the Senate, Mr. Jaroslav Kubera. Mr Kubera's speech was delivered by Jiří Oberfalzer, the Vice-President of the Senate. Other presenters were: Radek Vondráček, the Chairman of the Chamber of Deputies, Eva Pokorná, former prisoner of the Auschwitz-Birkenau extermination camp, Jana Horváthová, director of the Roma Museum, Michal Klíma, the Chairman of the FHV Board of Directors and Tomáš Kraus, the secretary of the Federation of Jewish communities.

The meeting was attended by survivors of the Shoah, representatives of the so-called second generation, children of survivors, students of Lauder schools, representatives of the state administration, ambassadors, the Archbishop of Prague, Chief Rabbi Sidon and the presidents of the Jewish Communities.

The organization of the event was supported by our volunteers.

Educational seminar in Auschwitz

The seminar is dedicated to the memory of Marta Kottová and Michal Salamonovič, the witnesses of Auschwitz-Birkenau, who were devoted in working with the students. They tirelessly shared their nightmarish experience with an aim to prevent the Holocaust from ever repeating again. We feel grateful to their work, and we are trying to continue in their effort.

We prepared the seminar together with a visit to the former Auschwitz-Birkenau extermination camp together with Erika Bezdíčková, and in cooperation with Zuzana Pavlovská, the head of the Department for Education and Culture of the Jewish Museum in Prague. Because of the pandemic, the seminar was not held. In September, we were struck by the news of Erika Bezdíčková's passing away. With our support, the Czech Auschwitz Committee published a book of her memoirs and so, even if we no longer make the educational journey together, her story will live on.

We Meet

A Lecture by Professor Ivan Rektor

On 9 January, 2020, on the premises of the Prague Jewish Community, we organized a lecture of Professor Dr. Ivan Rektor, CSc. The topic of the lecture was his research, which our foundation partially funded: The Lifelong Impact of Extreme Stress on the Human Brain – Psychological Profile and Structural Changes in the Brain of People who Survived Holocaust. The lecture was very interesting and enjoyed great interest from the attendees. The seminar was attended by 61 people.

I am Jewish, and I prosper - café sessions

In 2020, we organized 3 café sessions, moderated by Irena Kalhousová and Jan Fingerland:

The first panel was the February Café of 3 Generations, organized on the occasion of the Day of Remembrance of the Victims of the Holocaust and crimes against humanity. Academic painter Helga Hošková-Weissová, historian Martin Šmok and a hospital director, David Kosák, participated in the Café as panellists.

The second Café session, which took place in September, introduced





Šimon Pánek, a director of the organization People in Need, and Martina Pojarová, director of the nursing home.

The last online Café session was held in December and its panelists were stand-up comedian Michael Szatmary and journalist, Marek Tóda.

Chanukah Benefit Concert

Despite our plans and wishes, we could not organize the Hanukkah benefit concert in the traditional format. We organized the lighting of the Hanukkah lights together with the Federation of Jewish Communities in the Czech Republic and broadcast it online. During Hanukkah, we sold charity donuts and holiday cards. We asked the participants to send a gift or a donor SMS. In total, we collected CZK44,028.

GRANT OF THE MINISTRY OF CULTURE OF THE CZECH REPUBLIC

In December 2014, the FHV concluded a long-term cooperation agreement with the Ministry of Culture of the Czech Republic for the implementation of a multi-year project for the provision of foundation contributions in the Renovation, Remembrance and Future programmes. From 2015 to 2019, the FHV received an annual subsidy of CZK 20 million. On 3 June 2019, the Government of the Czech Republic decided, by Resolution No. 387, on further support for the FHV in the years 2020–2024 totaling CZK100 million. On 23 September 2019, an amendment was signed that extends the long-term cooperation agreement for another five years. On 6 May 2020, based on an approved statement of subsidy in 2019, we received an Approval of the Ministry of Culture on a provision of a non-investment subsidy from the state budget amounting almost CZK20,2 million for the calendar year 2020. With a use of the financial means from the subsidy we funded all projects in the Renovation, Reminder, and Future programs (including the sub-program Our Future). Of the CZK 20,201,581 provided, we did not spend the amount of CZK 980,368, while 13 projects were not implemented due to the Covid - 19 pandemic. In total, there were 110 projects financed by the Ministry of Culture grant. The funds also covered the FHV administrative costs. The project of providing endowment benefits in the Renovation, Remembrance and Future programs has already been successfully implemented 6th year in a row

The subsidy was audited by 22HLAV s.r.o. The Final Report and the account statement were submitted to the Ministry of Culture of the Czech Republic on 1 February 2021. The Auditor's Report was submitted on 11 February 2021.

We would like to thank the Ministry of Culture for their support and cooperation.

FINANCIAL REPORT AND AUDITOR'S REPORT

The FHV's financial statement was drawn up for period 1 January 2020 - 31 December 2020.

In 2000, the FHV received an endowment benefit amounting CZK300 million from the former State Property Fund, today's Ministry of Finance of the Czech Republic. These financial means are distributed in harmony with the stated grant rules on a yearly basis. A large part has already been distributed in endowment benefits, the remaining almost CZK35 million is invested in the portfolios of securities under the management of the investment company Conseq Investment Management, a. s.

On 29 January 2014, the contract on the transfer and use of financial means between the FHV and the Ministry of Finance of the Czech Republic was terminated. All unused funds remain in the administration of the FHV; the funds will further be administered as FHV's own funds.

In 2020, in the 19th call for proposals, a total granted amount was CZK20,884,000 (Including emergency assistance from the Czech-German Fund for the Future. For more information, see Chapter 10 Assistance During the Pandemic). Out of this, CZK16,721,000 was financed by the subsidy of the Ministry of Culture and CZK3,738,000 was financed from the FHV's own means. The remaining CZK431,000 was paid from the donation of the Public Benefit Society to support people affected by the Holocaust, from public collection and from the Czech-German Fund for the Future.

FHV's administrative costs for 2020 amounted to CZK3,613 thousand. Out of this sum, CZK982,000 was paid by the FHV from its own funds, CZK2,500,000 from the subsidy of the Ministry of Culture and CZK131,000 was paid from other external sources.
