In September this year we will mark 20 years since the Chamber of Deputies of the Parliament of the Czech Republic approved the allocation of the financial means to alleviate the injustices caused by the Holocaust. This resolution of the Parliament allowed the establishing of a Foundation for Holocaust Victims, which has been fulfilling this purpose by its activities. Since that parliamentary resolution, the Government has twice decided to allocate additional funds to the FHV. The second time the funds were allocated was last year. This Governmental resolution will allow the FHV to continue with its support between 2020 and 2024.

The preparation of the documents for the Governmental decision and the subsequent negotiations about the contract with the Ministry of Culture of the Czech Republic, which implements the decision of the Government, formed a part of the agenda of the Board of Directors and the Secretariat of the FHV. In addition, the FHV has been carrying out its main scope of activity, i.e. the provision of grants in its four programmes: Care, Remembrance, Renovation and Future. The details of the allocation of the funds shall be provided in this Annual Report.

In addition to providing grants, the FHV organized its own activities, as in other years. The activities were organized in accordance with the FHV mission. In 2019, the FHV also participated in organizing the commemorative event related to the Holocaust. The event took place on the anniversary of the liberation of the Auschwitz-Birkenau concentration camp on 27 January in the Senate of the Czech Parliament.

Due to its organizational nature, the FHV has its own funds deposited in securities. Although the FHV chose a very conservative financial strategy, the Fund succeeded to achieve the appreciation in excess of inflation (in 2019). Therefore, with regard to the preliminary caution, the Board of Directors decided (at the end of 2019) to implement the partial sale of securities so as to be fully cover the need for cash in the year 2020. Given the financial developments in the first half of 2020 and the decline in the prices of securities, the decision, the FHV had taken, proved correct.

This Annual Report contains information on the subsidies and donations, which the FHV acquired in 2019, and the information on how they were used. I sincerely thank all donors and believe that this report proves that we use their donated funds effectively.

Finally, I would like to thank to the employees of the FHV and the members of the Board of Directors and Supervisory Board, who have been devoting their time and effort to the Foundation. I would like to conclude remembering JUDr. Jaroslav Niklas, Ph.D, MBA, who had been with the FHV since its establishment. Unfortunately, in January this year, he passed away.

The FHV was established in 2000 by the Federation of Jewish Communities in the Czech Republic on the basis of the recommendation of the Joint Working Committee focusing on mitigating of some property Injustices to Holocaust Victims, to organize educational and cultural activities in the area of Judaism.

In the years 2001–2005 we administrated the Compensation program, in which we distributed CZK100 million among those, whose property in today's Czech Republic had been confiscated during WWII on the basis of racial laws and who were unable to retrieve it or receive other forms of compensation through the then applicable restitution laws or through the international agreements. The program has been closed for several years now and our Foundation is currently not dealing with claims of this kind in any way.

We support the projects by organizing our own activities, especially by organizing expert seminars for social workers, professional in the provision of care services and psychologists of Jewish organizations that provide care to the Shoah survivors and their families. We also organize and support the Mechanchim seminars for Jewish teachers, lecturers and community workers. In addition to care, we also focus on community development, preparing the café sessions (Three Generations and I am Jewish, and I Prosper) and celebrating Hanukkah in public spaces. Every year, together with the Federation of Jewish Communities in the Czech Republic, we organize a commemorative meeting on the occasion of The Day of Commemoration in Memory of Victims of the Holocaust and Prevention of Crimes Against Humanity on the premises of the Senate of the Czech Parliament. We held an educational seminar, which was part of a visit to the former Auschwitz-Birkenau extermination camp accompanied by an eyewitness.

The FHV is mainly funded from state resources. In the year 2000, the Government of the Czech Republic, transferred CZK300 million to the FHV's account from the National Property Fund.

In December 2014, the FHV signed an agreement with the Ministry of Culture of the Czech Republic on a five-year financing period in which a yearly endowment benefit, amounting CZK20 million, will be transferred to FHV's account. The Government finances the projects in all grant programs excluding the Care Program, which is financed from the FHV's own means. On 3 June 2019, the Government of the Czech Republic ruled, by Resolution No. 387, on the provision of further support for the FHV in the years 2020–2024 totaling CZK100 million. The subsidy will, once again, cover the Renovation Program, Remembrance Program, The Future Program, a Sub-Program Our Future and part of the administrative costs of the FHV.

Care, Remembrance, Renovation, Future and Our Future

The Foundation for Holocaust Victims supports projects based on a public tender. The call for proposals is announced once a year, usually in July, and the deadline for projects is September of the same year. The scope of the projects is then implemented during the following year.

The FHV supports projects prepared especially by organizations under the umbrella of the Federation of Jewish Communities in the Czech Republic, associations, public beneficial organizations, institutions established by the church, public service institutions, and allowance organizations. All organizations must have their registered seat in the Czech Republic. Natural persons are not entitled to ask for benefits. We only support projects that are realized within the territory of the Czech Republic.

The endowment benefits are granted for a period of 11 months, and in case of Care program the period is one calendar year.

We favor projects having various financing sources.

In Care, Remembrance and Renovation Programs, there is no limit for a maximum requested amount. The maximum amount of the endowment benefit within the Future and Our Future programs is CZK100,000. All applications are processed through Grantys – an Electronic Grant Database at <https://nfoh-granty.cz/>.

The applications are evaluated by the respective grant committees nominated by the FHV Board of Directors. The Board of Directors grants endowment benefits on the basis of their recommendation. There is no legal entitlement to the endowment benefit. The results of grant call are published on the FHV website and all applicants are informed in writing. We sign contracts with all of our successful

applicants. Afterwards, we follow and review the use of the monetary means during the implementation of the project. In case of any violation of contractual terms and conditions, we demand the return of the granted money. The supported organizations report to the FHV on the progress and present the FHV with final reports on the projects accompanied by the reports on the budget. All projects are subject to an audit. We actively participate in projects we support and in case the beneficiary asks, we help with the promotion of their projects.

Projects in the Reminder, Renovation and Future Programs (including the Our Future Sub-Program) are funded from the subsidies allocated to the FHV by the Ministry of Culture of the Czech Republic, the Care Program is financed from our own financial resources and the donations we receive.

In 2019, the FHV and the financial means from the subsidy received from the Ministry of Culture of the Czech Republic supported the total of 118 projects.

On 18 November 2019, the FHV Board of Directors selected 137 projects that will receive a support in 2020 in a total amount of CZK21,701,581.

CARE PROGRAM

For eighteen years we have been supporting projects that provide professional social care, health care and psychological care for Holocaust survivors and their families. Through collaboration with professionals, we strive to improve the quality of their lives and provide the best care at their old age. We shall not forget about the survivor's second generation. We financially support home care, nursing services, psychological aid, residential care, day care centers run by Jewish communities, social workers, social advisory services, personal assistants, medical care, occupational therapy, physiotherapy, rehabilitation, phone contact services and many other activation programs. The care for Holocaust survivors and their families has been our long-term priority.

We actively cooperate with the Federation of Jewish Communities, which coordinates the financing of care from the Claims Conference in the Czech Republic. In total, we support the care for about 350 clients.

From 2002-2019, we supported the projects with a total amount of CZK87.7 million.

REMEMBRANCE PROGRAM

Our support is aimed at projects emphasizing a dignified remembrance of Holocaust victims and the victims of Roma genocide during WWII. We focus our attention to the education of young people through supporting activities having an expert leadership and involving the participation of Shoah witnesses. We finance commemorative events and commemoration services, exhibitions, theme lectures, workshops, research papers, and publishing of books and publications.

From 2002–2019 we supported the projects with a total amount of CZK23.5 million.

RENOVATION PROGRAM

We support the restoration and maintenance of Jewish monuments throughout the Czech Republic. Our goal is to restore the monument to its original state when the monument was built or, if this is not feasible, we then restore the monument to the state that would capture the maximum of the architectonic, artistic and artisanal elements.

We finance the repairs of synagogues, rabbinic houses and Jewish cemeteries. We also support re-erection and repairs of knocked-down tombstones, restoration of valuable tombstones and reconstruction of fencing walls. Our financial means do not enable us to restore all tombstones, so we also support cemetery documentation in order to have a digital image of its look saved for the future generations. All projects are led by professionals.

Since 2002, we have supported the restoration of Jewish monuments in the amount of CZK152 million.

Along with our grant activities, we have spent many years preparing our own educational and cultural programs. We prepare the programs for our partner organizations, possibly in cooperation with them. We maintain contact with those organizations, we map the needs of their employees and actively look for ways to help, in particular Jewish organizations, in their work and activities. We are also well aware of the community overlap of our work. That is why we organize cultural events that help to enrich and improve community life in Jewish communities, at the same time we also help Jewish organizations with the preparation of projects that develop their social life.

We Educate

Workshops for Social Service Workers

The care for Holocaust survivors and their families has been our priority. We regularly organize education and meetings of social workers of Jewish communities in the Czech Republic. We prepare seminars with an accreditation of the Ministry of Labor and Social Affairs of the Czech Republic. Since 2014 we have also been organizing seminars with experts from abroad. In 2019, we prepared two accredited seminars and seminar with a foreign lecturer. The first meeting in the spring was on the topic of an "Individual Planning and AEDL Model and Inspiration Based on the German Practice". The lecturer was Mr. Miroslav Snášel. The aim of the workshop and lecture was to help the client find their sense in difficult life situations and thus contribute to the quality of their life. The seminar was attended by 16 people. The May seminar was led, for the second time in a row, by Moshe Teller, an art therapist and specialist from Jewish Care, a Holocaust survivors Centre in London, who has worked in mental health and Holocaust care since 1988. The topic of the seminar was "The Mental Health of Holocaust Survivors and



Their Families, the Manifestations of Trauma in Everyday Life.” The participants actively discussed the manifestations of trauma in everyday life, the behavior of survivors and the effect of the trauma on people in their close circle. Furthermore, the lecturer Moshe Teller focused on the transmission of trauma, a hierarchy of suffering, on the unwanted and unconscious self-replication of certain types of behavior of children of survivors and the characteristics manifested by the second generation, which is influenced by the negative experiences of their parents. The seminar was attended by 26 participants. The theme of the third autumn meeting was “The Joy as a Source of Motivation When Working in

Mechanchim Seminar for Teachers and Workers in Jewish Educational Organizations

Another year of the Mechanchim seminar was in the name of critical and structured thinking about community work. The seminar was attended by 25 representatives of Jewish communities from all over



Helping Professions with a Focus on Self-Reflection – Introductory Seminar”. The participants had the opportunity to look at the theme from the point of view of a complex approach to a person in the context of self-reflection. The seminar was led by Mr. Miroslav Snášel and was attended by 11 participants.

They tirelessly shared their nightmarish experience with an aim to prevent the Holocaust from ever repeating again. We feel grateful to their work and we are trying to continue in their effort.

We Meet

Café Sessions “I am Jewish, and I Prosper.”

In 2019, we organized 3 café sessions “I am Jewish, and I Prosper.” The project already constitutes a stable and well-established brand among the Jewish cultural events organized for public and is in the general awareness of the Jewish community. For the last 2 years we have made two major change in the project. We started to involve younger participants and tried to attract younger visitors to attend our café sessions. Furthermore, we moved the café sessions to the Hybernská Campus, a new cultural center of the Prague Charles University. This place is currently very popular and is perceived as a space for interesting and progressive cultural events. Thanks to these two actions, we have managed to bring more younger people to attend our events. Moreover, the café sessions keep a regular content





structure. All the discussions we organized this year had the hosts talking about their profession, their Jewish roots and the way Judaism influenced or influences their lives. They talked about the way they pass on (or not) the traditions to their children and about their relation to Israel. Last year, we organized the following panel sessions hosting these couples:

Grant of the Ministry of Culture of the Czech Republic

On 18 December 2014, the FHV signed an agreement with The Ministry of Culture of the Czech Republic on a long-term partnership on a project called "Provision of Endowment Benefits in FHV Programs – Renovation, Remembrance and Future." We have been successfully implementing the project for the fifth year.

Based on an approved statement of subsidy in 2018, on 3 May 2019, we received an Approval of the Ministry of Culture on a provision of a non-investment subsidy from the state budget amounting almost CZK20,5 million for the calendar year 2019. With a use of the financial means from the subsidy we funded all projects in the Renovation, Reminder, and Future programs (including the sub-program Our Future). Out of the granted CZK20,486,292 million we did not manage to use CZK205,047. In total, there were 104 projects financed by the Ministry of Culture grant. The funds also covered the FHV administrative costs.

The subsidy was audited by 22HLAV s.r.o. The Final Report and the account statement were submitted to the Ministry of Culture of the Czech Republic on 30 January 2020, the Audit Report was submitted on 26 February 2019.

As part of the audit, we carried out the following works:

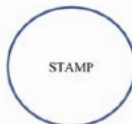
1. Verification of the fact that a separate accounting record has been kept
2. Verification of the fact that only eligible expenditures have been accounted for
3. Verification of the fact that the declared eligible expenditures in the specified period have been reimbursed in accordance with the terms of the legal act
4. Verification of the fact that the object of the subsidy corresponded to the approved purpose
5. Verification of compliance with other relevant legal act conditions

Conclusion

Based on the results of the applied auditing procedures, we did not find any significant fact, which would indicate that the accounting records have not been kept in accordance with the applicable laws and the terms of the management of state subsidies by the designated competent decision. The organization compiled the attached Bill of the project costs for a year 2019 in accordance with accounting. Total reported recognizable and, at the same time, subsidized cost of projects is CZK 20,281,245. In our opinion, this Bill of the project costs **gives, in all material respects, true and fair view of the costs of the above projects and the management of this subsidy is in accordance with the laid down conditions.**

FINANCIAL REPORT

The FHV's financial statement was drawn up for period from 1 January 2019 – 31 December 2019.

In 2000, the FHV received an endowment benefit amounting CZK300 million from the former State Property Fund, today's Ministry of Finance of the Czech Republic. These financial means are distributed in harmony with the stated grant rules on a yearly basis. A large proportion of these financial means have been distributed as part of the endowment benefits; the remaining CZK37 million is invested in shares. These funds are administered by the Conseq Investment Management, a.s. and a ČSOB Asset Management a.s.

On January 29 in 2014, the contract on the transfer and use of financial means between the FHV and the Ministry of Finance of the Czech Republic was terminated. All of the unused funds remain in the administration of the FHV; the funds will further be administered as FHV's own funds.

In 2019, in the 18th call for proposals, a total granted amount was CZK21,781 thousand – out of this sum, CZK17,781 thousand was financed by the subsidy of the Ministry of Culture and CZK3,738 thousand was financed from the FHV's own means. The remaining CZK262 thousand was paid from the donation of the Public Benefit Society to support people affected by the Holocaust and the Public Collection.

The FHV administrative costs in 2019 amounted to CZK4,052 thousand. Out of this sum CZK1,250 thousand was paid by the FHV from its own funds, CZK2,500 thousand from the subsidy of the Ministry of Culture and CZK302 thousand was paid from other external sources.

Report on the verification of financial statements

Auditor's opinion

We have audited the accompanying financial statements of the FOUNDATION FOR HOLOCAUST VICTIMS organization (hereinafter referred to as "the Organization") compiled on the basis of Czech accounting legislation, which consists of the balance sheet to 31 December 2019, the statement of profit and loss for the year ended 31 December 2019 and the notes to these financial statements, including a summary of significant accounting policies and other explanatory information. The data on the Organisation constitute a part of the annexes to this financial statement.

In our opinion, the financial statement gives a true and fair view of the assets and liabilities of the FOUNDATION FOR HOLOCAUST VICTIMS to 31 December 2019, and costs and revenues and financial results for the year ended 31 December 2019 in accordance with Czech accounting legislation.

Basis for the opinion

We conducted our Audit in accordance with the Act on Auditors, the Regulation of the European Parliament and of the Council (EU) No. 537/2014 and Auditing Standards of the Chamber of Auditors of the Czech Republic, which are international standards for Audit (ISA), where appropriate, supplemented and modified by the related application guidance. Our responsibility provided for by these regulations is described in more detail in the Auditor's responsibility for auditing the financial statements. In accordance with the Act on Auditors and the Code of Ethics adopted by the Chamber of Auditors of the Czech Republic, we are independent from the Organization and we fulfilled other ethical obligations resulting from those provisions. We believe that the Audit evidence we have gathered provides a sufficient and appropriate basis for our statement.

Other information contained in the annual report

The term "other information", in accordance with Section 2 (2) (B) of the Act on Auditors refers to the information contained in the annual report outside the financial statements and our Auditor's Report. The Board of Directors of the Organisation shall be responsible for the other information.

Our opinion on the financial statements does not relate to the other information. Nevertheless, it is part of our responsibilities associated with the verification of the financial statements to get acquainted with the other information and consider whether the other information is not in a material misstatement with the financial statements or with our knowledge of the entity gained during the Audit of the financial statements or whether this information does not appear as a material misstatement. We also assess whether other information was in all important (material) aspects, prepared in accordance with the relevant legislation. This assessment means whether the other information meets the requirements of the legislation on the formalities and the procedure for the preparation of the other information in the context of the materiality, that is, whether any non-compliance with those requirements would be eligible to influence the judgment made on the basis of other information.

Furthermore, we are required to state whether, on the basis of knowledge and awareness about the Organization to which we have reached in the implementation of the Audit, the other information does not contain material misstatements. **We have not identified any material misstatements in the other information received under these procedures.**

Responsibility of the Board of Directors and the Supervisory Board of the Organisation for the financial statements

The Board of Directors of the Organisation shall be responsible for the preparation of the financial statements giving the true and fair view in accordance with Czech accounting legislation and for such internal inspection system that it considers necessary for the preparation of financial statements so as to not contain any significant material misstatement caused by fraud or error.

In preparing of the financial statements the Board of Directors of the Organization is required to assess whether the Organization is able to continue as a going concern and, if relevant, describe in the notes to the financial statements matters relating to its ability to continue as going concern and the use of the assumption of the going concern during the preparation of the financial statements, with the exception of cases when the Board of Directors plans to abolish the Organization or termination of its activity, respectively, when it has no realistic option but to do so.

The Supervisory Board shall be responsible for overseeing the financial reporting process in the Organisation.

Auditor's responsibility for auditing financial statements

Our goal is to obtain reasonable assurance that the financial statements as a whole, does not contain a material misstatement caused by fraud or error, and to issue the Auditor's Report containing our opinion. A reasonable degree of assurance is a large degree of certainty; however, it is not a guarantee that an Audit conducted in accordance with the above provisions, in all cases, in the financial statements will reveal any existing material misstatement. Misstatements can arise from fraud or error and are considered material misstatements, if it is realistic to assume that, individually or in the aggregate, such misstatements could influence the economic decisions that users of financial statements adopt on its basis.

In the implementation of the Audit in accordance with the above provisions, it is our duty to apply throughout the audit, professional judgment and maintain professional scepticism. Furthermore, it is our duty to:

- Identify and assess the risks of material misstatement of the financial statements caused by fraud or error, design and perform Audit procedures responsive to those risks and obtain sufficient appropriate Audit evidence, so that we can, on its basis, express an opinion. The risk that we would not detect material misstatement, which occurred as a result of fraud, is greater than the risk of undetected material misstatement caused by error, because part of the fraud may be the secret agreement (collusion), forgery, intentional omissions, misrepresentations, or circumvention of internal controls by the Board of Directors.

- To assess the appropriateness of used accounting policies, reasonableness of accounting estimates made the information in this context, the Board of Directors of the Organisation stated in the notes to the financial statements.
- Assess the suitability of using the assumption of the going concern when preparing financial statements by the Board of Directors and whether with regard to the collected evidence there is a material misstatement arising from events or conditions that may significantly challenge the ability of the Organization to continue as a going concern. If we come to the conclusion that such a material misstatement exists, it is our duty to draw attention in our report on the information referred to in this context in the annex of the financial statements, and if such information is not sufficient to express a modified opinion. Our conclusions concern the ability of the Organization to continue as a going concern based on the Audit evidence we obtained by the date of our report. However, the future events or conditions can lead to the fact that the Organization loses the ability to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the annex, and further evaluate whether the financial statements show the underlying transactions and events in a way that leads to the true view.

It is our duty to inform the Board of Directors and the Supervisory Board, inter alia, on the planned scope and timing of the Audit and on the significant findings, which we in the course have made, including identified significant deficiencies in the internal control system.
