Eva Jelínková

What does the family Shoah experience mean to you?

The family experience of the Shoah means for me constant remembrance of my parents, aunts and other family members who survived the Shoah, and of those members of my family who ended their lives in Nazi concentration camps. It also represents the attitudes that I take towards everything that I encounter in my life. Whether it is the joyful events, which I am aware of doubly, or the unpleasant situations, which I try to overcome while being aware of what my loved ones had to go through.

What have you learned from your parents/grandparents that you would like to pass on?

My parents taught me love, humility and respect for all people who deserve it. I also learned to have a critical eye and to defend myself against lies, pretense and evil, even if it was all wrapped up in nice words about the good intentions of those who spread these attributes. I try to pass all this on to my children and grandchildren.

What is important to you in life?

For me, the most important things in life are the health and happiness of my family, strong relationships with friends and feeling good about my work, which is very important to me.

What does the family Shoah experience mean to you?

Four of my grandparents survived the war by hiding – in the cellar, in the mountains, in the rectory or on the farm. None of them were in a concentration camp. My family's experience, then, does not involve so much the horrific conditions and loss of human dignity, but rather the pervasive fear and pain of losing my family.

What have you learned from your parents/grandparents that you would like to pass on?

They taught me that the children come first. I learned the importance of education and hard work, but also how to talk lovingly and openly within the family. My grandmother taught me how to bake barches, make matzo dumplings or light Shabbat candles. On the other hand, they also taught me fear – not to say that I was Jewish, preferring not to talk about it and not to demonstrate it in public. To this day, it is still natural for me not to talk about my background outside of the community. But this is not something I would like to pass on.

What is important to you in life?

The most important thing to me are my three children, my still active parents, my good friends, and I enjoy and find fulfillment in my work – caring for the little ones in our community and being able to create a gateway for them into the world of Jewish education. The bonus of this work is the powerful experiences through the children's encounters with Hagibor clients, some of whom are Shoah survivors.

Emma Günsberger

What does the family Shoah experience mean to you?

For me, the family experience of the Shoah is a severe trauma that I am sometimes not even aware of, but it finds a way to manifest itself. But it also means a great commitment to me. I am part of the last generation that had the opportunity to meet Shoah survivors and hear their stories live. It is my responsibility to make sure that these memories are not forgotten. Moreover, I feel a great obligation not to condone the violation of the human rights of others, but to speak up and fight back in some way.

What have you learned from your parents/grandparents that you would like to pass on?

Both my parents and my grandparents placed good family relationships as their primary value. They anchored in me a strong sense of Jewish identity and belonging. They introduced me to the charms of community life. My family taught me to be polite and respectful, but also to be wary of any extremes. I would like to pass on similar values.

What is important to you in life?

What my ancestors were deprived of – freedom, health and truth. In everyday life, family and friendship, solidarity and contentment.

What does the family Shoah experience mean to you?

For me, my family's experience of the Shoah makes me realize how incredibly lucky it is to live in a time when I am not persecuted for my origins and do not have to hide them. For me, it simply means gratitude for being able to live a free life, unlike my ancestors.

What have you learned from your parents/ grandparents that you would like to pass on?

I learned from my parents to respect other people. I also learned to help others when they are in need. And last but not least, I learned to be forgiving – to find enough perspective within myself to forgive others. Of my grandparents, unfortunately, I only experienced my mother's mother. However, she inspired me with her life story, which abounded with resilience and courage. My grandmother always impressed upon me that these are necessary attributes to make it in life.

What is important to you in life?

In life, it is important for me to appreciate people I know I can count on. These are mainly family and close friends. I also find it important not to dismiss people with opposing views and to try to understand them. In these times, when the social divide is only getting worse, I find this particularly important.

What does the family Shoah experience mean to you?

Regardless of the indescribable suffering of an entire nation, the horrors and losses even in our extended family, I am humbly grateful for the fact that my father's immediate family survived and were all able to reunite – his parents and sisters – back in their home after liberation and I was able to live with them and share their experiences.

What have you learned from your parents/ grandparents that you would like to pass on?

Humility, gratitude, civility and tolerance.

What is important to you in life?

Life itself and health. Everything else depends on that – living a happy life with my family, in close connection with members of the community, especially the older generation whose lives I have the opportunity to document. I enjoy civility, tolerance, non-confrontation, and I admire the roots of our community, which is why I enjoy being in the company of Hasidim so much, and not just professionally.

What does the family Shoah experience mean to you?

We need to cherish our freedom, and when it is in peril, we must not hesitate to fight for it, so that we may never again be as defenseless as ", the sheep to the slaughter".

What have you learned from your parents/grandparents that you would like to pass on?

Back then, a person who thought only of oneself could not survive in the camp. Solidarity, cooperation, empathy saved the day. And so it is today, even though it is not yet a matter of life... It is necessary to help because we never know when we ourselves will need help.

FOREWORDS OF THE CHAIRMAN OF THE BOARD OF DIRECTORS



In 2022, the Foundation for Holocaust Victims continued to fulfill its mission of supporting survivors of Nazi persecution, the preservation and renovation of Jewish monuments, the fight against racism, and Jewish life. In this Annual Report, allow us to present you with the details regarding the projects we supported last year. The activities of the FHV are not only important because of the support we provide, but also because they exemplify successful and beneficial cooperation between the government and the Jewish community. The activities of the Fund are governed by the Board of Directors, which consists of representatives nominated by the State, namely the Office of the Government, the Ministry of Foreign Affairs, the Ministry of Finance and the Ministry of

Culture, accompanied by the representatives nominated by the Federation of Jewish Communities in the Czech Republic.

The establishment and activities of the Foundation were linked to the personality of Professor Felix Kolmer, who was the founder of the Foundation for Holocaust Victims in year 2000 and served as a Honorary Chairman of the FHV Board of Directors for many years. A year ago, in May, we celebrated his 100th birthday with him. He died a quarter of a year later. Until the very last moment, he took a keen interest in the work of the Foundation, and if he could no longer attend the Board meetings in person, he at least connected via the Internet. Felix Kolmer lived through Nazi persecution at its worst. He was forced to take the first transport to the Terezín concentration camp. Later, he was deported to the Auschwitz-Birkenau extermination camp but survived. His mother and other relatives, though, did not survive the concentration camp. In spite of these horrible experiences, Felix Kolmer was one of the people who significantly contributed to the improvement of Czech-German relations after 1989 and to the functioning of institutions and initiatives that mitigated the effects of the Nazi terror in our country.

The Annual Report is a document that usually presents the activities of an organization focusing mainly on numbers – costs and income. There are always specific people behind successful activities, though. Those whose efforts produce positive results. That is why I have remembered of Felix Kolmer in this year's foreword.

MISSION STATEMENT AND ACTIVITIES

We mitigate the injustices of the past, we think about the future

The FHV was established in 2000 by the Federation of Jewish Communities in the Czech Republic on the basis of the recommendation of the Joint Working Committee focusing on mitigating of some property Injustices caused to Holocaust Victims.

The primary purpose of the FHV is to provide endowment benefits. For more than 20 years, we have been providing endowment benefits supporting social and health care with special attention to the needs of Holocaust survivors, for the reconstruction, renovation and preservation of movable and immovable Jewish monuments in the Czech Republic, for projects serving to commemorate the victims of the Holocaust with dignity, for educational activities in the field of Judaism and for the development of Jewish communities in the Czech Republic.

We support the projects by organizing our own activities, especially by organizing expert seminars for social workers, carers and psychologists of Jewish organizations that provide care to the Shoah survivors and their families. We also organize and support the Mechanchim seminars for Jewish teachers, lecturers and community workers. We also focus on the community development, organize discussion cafes (Three Generations, I am Jewish and I Prosper, Discussions not only for Children of Maislovka), celebrate Hanukkah in public space and organize volunteer maintenance work in Jewish cemeteries. Every year, together with the Federation of Jewish Communities in the Czech Republic, we organize a commemorative meeting on the occasion of The Day of Commemoration in Memory of Victims of the Holocaust and Prevention of Crimes Against Humanity on the premises of the Senate of the Czech Parliament. We organize educational trips connected with a visit to the former Auschwitz-Birkenau extermination camp.

In the years 2001–2005 we administrated the Compensation program, in which we distributed CZK100 million among those, whose property in today's Czech Republic had been confiscated during WWII on the basis of racial laws and who were unable to retrieve it or receive other forms of compensation through the then applicable restitution laws or through the international agreements. The program has been closed for several years now and our Foundation is currently not dealing with claims of this kind in any way. The FHV is mainly funded from state resources. In the year 2000, the Government of the Czech Republic, transferred CZK300 million to the FHV's account from the National Property Fund.

In December 2014, the FHV signed an agreement with the Ministry of Culture of the Czech Republic on a five-year financing period in which a yearly endowment benefit, amounting CZK20 million, was transferred to FHV's account. The Government finances the projects in all grant programs excluding the Care Program, which is financed from the FHV's own means. On 3 June 2019, the Government of the Czech Republic by Resolution No. 387 decided on further support for the NFOH in the years 2020–2024 in the total amount of CZK100 million. The subsidy will again cover the Renovation Program, Remembrance Program, The Future Program, a Sub-Program Our Future and part of the administrative costs.

GRANT PROGRAMS

Care, Remembrance, Renovation, Future and Our Future

The Foundation for Holocaust Victims supports projects based on a public tender. The call for proposals is announced once a year, usually in July, and the deadline for projects is September. The projects are realized during the following year.

The FHV supports projects prepared especially by organizations under the umbrella of the Federation of Jewish Communities in the Czech Republic, associations, public beneficial organizations, institutions established by the church, public service institutions, and allowance organizations. All organizations must be registered in the Czech Republic. Natural persons are not entitled to ask for benefits. We only support projects that are realized within the territory of the Czech Republic.

The endowment benefits are granted for a period of 11 months. In case of the Care program the period is one calendar year. In Care, Remembrance and Renovation Programs, there is no limit

for a maximum requested amount. The maximum amount of the endowment benefit within the Future Program is CZK50,000 and Our Future Sub Program is CZK100,000.

We preferentially support projects with multi-source funding.

All applications are processed through Grantys – an Electronic Grant Database at https://nfoh-granty.cz/.

The applications are evaluated by the respective grant committees nominated by the FHV Board of Directors. The Board of Directors grants endowment benefits on the basis of their recommendation. The results of grant call are published on the FHV website and all applicants are informed in writing.

We sign contracts with all of our successful applicants. Afterwards we follow and review the use of the monetary means during the implementation of the project. The supported organizations present the FHV with progress and final reports on the projects, as well as reports on the budget. In case of any violation of contractual terms and conditions, we demand the return of the granted money. All projects are subject to an audit. We actively participate in projects we supported and in case the beneficiary is interested, we help with the promotion of the projects. Projects in the Reminder, Renovation and Future (including the Our Future sub-program) are funded by the Ministry of Culture grants, the Care program is financed from our own financial resources and the donations we receive.

In 2022, the FHV and the financial means from the subsidy received from the Ministry of Culture of the Czech Republic supported the total of 139 projects.

On 5 December 2022, the FHV Board of Directors selected a total of 123 projects to be supported in 2023 with a total amount of CZK22,684,883.

WE CARE

For over twenty years we have been supporting projects that provide social, medical and psychological care for Holocaust survivors and their families. Through collaboration with professionals, we strive to improve the quality of lives of the Shoah survivors and provide the best care at their old age. We shall not forget about the survivor's second generation. We financially support home care, nursing services, psychological aid, residential care, day care centers run by Jewish communities, social workers, social advisory services, personal assistants, medical care, occupational therapy, physiotherapy, rehabilitation, phone contact services and many other activation programs. The care for Holocaust survivors and their families has been our long-term priority.

CARE PROGRAM



We cooperate with the Federation of Jewish Communities, which coordinates the financing of care from the Claims Conference in the Czech Republic. In total, we support the care for about 300 clients.

From 2002–2022, we supported the projects with a total amount of CZK99.7 million.

We support the restoration and maintenance of Jewish monuments throughout the Czech Republic. Our goal is to restore the monument to its original state when the monument was built or, if this is not feasible, we then restore the monument to the state that would capture the maximum of the architectonic, artistic and artisanal elements. We finance the repairs of synagogues, rabbinic houses and Jewish cemeteries. We also support re-erection and repairs of knocked-down tombstones, restoration of valuable tombstones and reconstruction of fencing walls. Our financial means do not enable us to restore all tombstones, so we also support cemetery documentation in order to have a digital image of its look saved for the future generations. All projects are led by professionals.

Since 2002, we have supported the restoration of Jewish monuments in the amount of CZK191.1 million.

PROJECTS OF OUR OWN

The projects we support are complemented by the organization of our own educational and cultural programs. We prepare the programs for our partner organisations, possibly in cooperation with them. We have regular contact with organizations, mapping their needs and actively seeking ways to help them in their work. We are well aware of the community overlap of our work. Therefore, we organize activities that help to enrich and improve the community life of Jewish organizations, while at the same time help them to prepare projects that develop their own social life.

WE EDUCATE

Workshops for Social Service Workers

The care for Holocaust survivors and their families has been our priority. We regularly organize education and meetings of social workers of Jewish communities in the Czech Republic. We prepare seminars with an accreditation of the Ministry of Labor and Social Affairs of the Czech Republic. Since 2014 we have also been organizing seminars with experts from abroad.

In 2022, we prepared two accredited seminars and seminar with a foreign lecturer.

Accredited seminar on How to talk to Someone in Crisis 1 was held in March. The lecturers were Barbora Hrušková and Gabriela Špačková from Gaudia organization. The aim of the seminar was to focus on specific practical tools for working with clients in challenging/crisis situations.



The main focus was on sharing experiences from practice and exploring how to translate the tools into concrete experience of the participants. The seminar was attended by 17 workers. In December, we held a seminar on the impacts of the transgenerational emotional heritage of the Nazi era on the descendants of the persecuted. The seminar was led by Peter Pogany-Wnendt, a physician and psychotherapist in private practice in Cologne, Germany. Also, a Chairman of the Working Group on the Intergenerational Consequences of the Holocaust and the son of Jewish Holocaust survivors from Hungary.

In the morning session, Peter Pogany-Wnendt presented the psychological effects and mechanisms of transgenerational transmission of trauma to the descendants of Holocaust survivors. He spoke about his many years of experience, about the manifestations of trauma in everyday life, mental well-being, and the behavior of survivors and descendants of persecuted persons who carry in their souls the emotional consequences of the unprocessed experience of the persecution of their parents and grandparents during the Holocaust. The afternoon session was conducted in the form of a workshop with the aim of deepening the topic and putting it in the perspective of practical work with Holocaust survivors. The seminar was attended by 20 people.

Mechanchim Seminar for Community Workers and Teachers in Jewish Educational Organizations

The 10th annual Mechanchim seminar for Jewish community workers took place in November. With Ethel Barylka from Educating for Impact, we discussed how to best target our community programs to specific target groups and how not to stay in place and dynamically change programs according to the changing needs of the community. In the second part, we looked for effective strategies to overcome the challenges we face as community workers. The seminar was attended by community workers and volunteers from the Prague Jewish community and organizations associated with the Federation of Jewish Communities in the Czech Republic.

We are grateful for the cooperation and support of the American Jewish Joint Distribution Committee and the Jewish Museum in Prague for providing the space. We have expanded Mechanchim to include a meeting called the Beit Café, where we discussed community plans and coordinated activities before each holiday.



WE REMEMBER

The Holocaust Remembrance Day and the Day of Prevention of Crimes Against Humanity

In cooperation with the Federation of Jewish Communities in the Czech Republic, we organized a traditional Holocaust Remembrance Day and the Day of Prevention of Crimes Against Humanity in the Senate of the Czech Republic, held with the auspices of its President, Miloš Vystrčil, on 27 January 2022. Unfortunately, due to the culminating pandemic, the meeting was held without invited guests and was broadcast live on the Czech Television (ČT24).

Yom ha-Shoah

Together with the Federation of Jewish Communities in the Czech Republic and the Vice-President of the Senate of the Czech Republic, Jiří Oberfalzer, we organized a meeting of Shoah survivors on 27 April on the occasion of Yom ha-Shoah in ha-gvura, Holocaust and Heroism Day according to the Israeli calendar.

We would like to thank Tereza Kotláriková and the Senate of the Czech Republic for their cooperation, the Ministry of Culture of the Czech Republic and the Jewish Community in Prague for their support.





Educational Trip to Auschwitz

The project is dedicated to the memory of Marta Kottová and Michal Salamonovič, Auschwitz-Birkenau survivors who tirelessly passed on their horrific wartime experience with the goal that the Holocaust would never be repeated in any form. We feel grateful to their work and we are trying to continue in their effort.

We went on a three-day trip together in May, visited the State Museum and commemorated the victims of the Shoah in Birkenau. We focused on the personal family stories of the participants, and we had the opportunity to listen to the personal story of Rudolf Wittenberg, a survivor of the Terezín ghetto. We visited the old Jewish cemetery, the last synagogue in Auschwitz and met with the project coordinator of the International Youth Centre in Auschwitz, where we were staying. The project was attended by 22 members of the Teplice and Prague Jewish communities, mainly members of the so-called second generation.



Meeting of Shoah Survivors with the Presidents of the Czech Republic and Israel

We were approached by the Office of the President of the Czech Republic to cooperate with the organization of a meeting between the survivors and the presidents during the one-day state visit of Israeli President, Yitzhak Herzog. We arranged for the participation of survivors and the logistics of the entire meeting, which took place on 11 June 2022. The presidents reserved 30 minutes of their time for a personal and very friendly meeting.





WE MEET

Discussion Cafés

We have been organizing the Cafés together with Irena Kalhousová since 2012. We will have three types of discussions: the Three Generations Café, I'm Jewish and I Prosper, and the Discussion Not Only for the Children of Maislovka, hosted by Petr Brod.

In April, on the occasion of the Lost Europe photography exhibition, we organized the I'm Jewish and I Prosper Café session at the Prague Creative Centre (Scout Institute), to which Karel Cudlín and Jan Dobrovský were invited.

Prior to the Jewish New Year, doctors Elen Novotová and Mikuláš Kosák, accepted an invitation to the I am Jewish and I Prosper Café session in the place called the "Background".

The Generation Café was moderated by Irena Kalhousová at the Štetl Fest festival in Brno on 3 September 2022.

In December, we prepared two discussion cafés at the Jewish Community in Prague for the Hanukkah holiday. The first debate with Bozena Steinerová was led by Petr Brod, the second by Irena Kalhousová with Dominika Weiss Hošková and Robert Fischmann. During the evening we lit the Hanukkah lights together with the Chief Provincial Rabbi, Karol E. Sidon.

Celebrating 100th Birthday of Professor Felix Kolmer

In cooperation with the Czech Auschwitz Committee, we prepared a beautiful celebration of Professor Kolmer's 100th birthday. The celebration was accompanied by the presentation of Felix Kolmer's book: The Promise.





Volunteer Work at the Cemeteries

In cooperation with the Administration of Property (Buildings and Cemeteries) of the Jewish Community in Prague, we organized a one-day volunteer workday at the Jewish cemetery in Kovanice, completing the work started in the previous year. The tombstones in the cemetery and the fence wall were completely cleaned.

Thank you to all the volunteers! We would like to thank the Foundation of the Jewish Community in Prague for their support.

Purim Benefit

Due to anti-pandemic measures, we held the benefit on Purim instead of Hanukkah and combined it with the traditional celebration of the holiday. Chief Rabbi Karol E. Sidon, the Chief Rabbi, read the Megillat Ester. The Mackie Messer klezmer band and Bengas played to dance. The evening was conducted by Soňa Beaumont and Jiří Valeš. We have collected the donations in the total amount of CZK50,406 for the so much needed care. However, the festive evening was fundamentally marked by Russian aggression in Ukraine, with those present expressing the wish that the aggressor would soon be defeated like the evil Haman. The evening was also attended by several refugees from Ukraine.



GRANT OF THE MINISTRY OF CULTURE OF THE CZECH REPUBLIC

In December 2014, the FHV concluded a long-term cooperation agreement with the Ministry of Culture of the Czech Republic for the implementation of a multi-year project for the provision of foundation contributions in the Renovation, Remembrance and Future programmes. From 2015 to 2019, the FHV received an annual subsidy of CZK 20 million. On 3 June 2019, the Government of the Czech Republic decided by Resolution No. 387 on further support for the FHV in the years 2020–2024 totaling CZK100 million. On 23 September 2019, an amendment was signed that extends the long-term cooperation agreement for another five years.

On the basis of the approved settlement of the subsidy from 2021, on 20 April 2022, we received the Decision of the Ministry of Culture of the Czech Republic on the provision of a non-investment subsidy from the state budget in the amount of CZK 20 million for the calendar year 2022.

With a use of the financial means from the subsidy we funded all projects in the Renovation, Reminder, and Future programs (including the sub-program Our Future). Of the CZK 20 million provided, we did not spend CZK188,605 and 5 projects were not implemented. In total, there were 126 projects financed by the Ministry of Culture grant. The funds also covered the FHV administrative costs

The project of providing endowment benefits in the Renovation, Remembrance and Future programs has already been successfully implemented 8th year in a row.

We would like to thank the Ministry of Culture for their support and cooperation.

The total reported allowable and subsidized project costs amount to CZK 19,811,394.89. In our opinion, this Grant Cost Accounting fairly presents, in all material respects, the costs of the above projects and the management of this grant is in accordance with the terms and conditions.

FINANCIAL REPORT AND AUDITOR'S REPORT

The FHV's financial statement was drawn up for period from 1 January 2022 - 31 December 2022.

In 2000, the FHV received an endowment benefit amounting CZK300 million from the former State Property Fund, today's Ministry of Finance of the Czech Republic (hereinafter as a MF). These financial means are distributed in harmony with the stated grant rules on a yearly basis. A large part has already been distributed in endowment benefits, the remaining almost CZK25,8 million is invested in the portfolios of securities under the management of the investment company Conseq Investment Management, a. s.

On 29 January 2014, the contract on the transfer and use of financial means between the FHV and the Ministry of Finance of the Czech Republic was terminated. All of the unused funds remain in the administration of the FHV; the funds will further be administered as FHV's own funds.

In 2022, a total of CZK21,259,000 was distributed in the 21st Call. Out of this amount, CZK17,311,000 was financed by the Ministry of Culture of the Czech Republic, CZK3,675 thousand was paid from the FHV's own funds. The remaining CZK273,000 was covered by the Public Collection, a private donor and a donation from the Public Benefit Society for the Support of Persons Affected by the Holocaust.

The FHV administrative costs in 2022 amounted to CZK4,222,000. Out of this sum CZK1,472,000 was paid by the FHV from its own funds, CZK2,500,000 from the subsidy of the Ministry of Culture and CZK250,000 was paid from other external sources.

civilian sphere, he worked as a psychologist for the Ministry of Internal Affairs, as the head of the Information Office of the Ministry of Culture and as the head of the Office of Professor Jan Švejnar. From 2010 to 2013 he was director of the Institute for the Study of Totalitarian Regimes. In the 2013-2017 parliamentary elections, he was a member of parliament for the Christian Democrats in Prague. From 29 January 2014 to 13 December 2017 he was the Minister of Culture of the Czech Republic in the coalition government of Bohuslav Sobotka. Since 2019, he has been a member of the Government Council for Human Rights. He is also a member of the Council of the Czech-German Discussion Forum at the Ministry of Foreign Affairs, and since 2021 he has been Honorary Consul of the Principality of Liechtenstein in the Czech Republic. As a self-employed person, he is also engaged in lecturing and consulting activities.

Ing. Vlastislav Ouroda, Ph.D.



Since 2015, he has been working as Deputy Minister of Culture for cultural heritage. Since 2020, he has been responsible for the agenda of State-Funded Institutions. Prior to joining the Ministry of Culture, he worked in Monument care (since 1991) in a number of positions, especially in the National Heritage Institute (castle warden, official, survey processor, head of department, deputy director and then director of the territorial office). In 2009 he graduated from the doctoral study program at the Faculty of Architecture of the Czech Technical University in Prague. He is a member of the International Council on Monuments and Sites (ICOMOS), where he works, among others, in International Committee on Historic Towns and Villages - CIVVIH (expert member). Since 2015, he has also been Vice-President of the Czech National Committee within this international organization. He is a member of the Czech UNESCO Commission. In his professional activities, he focused mainly on areas closely linked to the practical protection of the physical nature of monuments, in particular on surveys of endangered immovable monuments and on the care of protected areas, including the reflection of the effectiveness of methods of regulation of valuable historical urban units.


Bc. Ester Karasová, Financial Manager
